Brown, Matt

1. An important value of this campaign is that we're better, together. I believe that there isn't a challenge or opportunity London faces that can't be met if we break down silos, and leverage the strengths we have within our community.

The role of the non-profit sector in economic revitalization and in promoting overall quality of life within London is clear. I will ensure that the sector is engaged in the important issues facing London.

The 'Collaborating for Community Impact' model being championed by Pillar is exactly how London needs to approach the challenges and opportunities it faces. If we build strong partnerships of respect and collaboration between the private, public and non-profit sector, there isn't a community challenge or opportunity that we can't meet.

2. The non-profit and charitable sector in London is incredibly vibrant. It gives all Londoners so many ways to support the causes that matter to them in the ways that work best for their families. From giving of time to making financial contributions, there are so many ways to help.

For our family, we are fortunate to be able to support many causes in our community consistently, in fact I've been a community volunteer for the past twenty years. A few examples include:

- One of my personal heroes is Terry Fox and supporting the London run is something I do every year, through donations and whenever possible, running the course.

Gardner, Steve

1. Currently the city of London helps out almost 120 nonprofit originations and invests just over \$2.7 million. This money goes and helps out the arts to festivals and many other types of projects. The Arts and festivals are a big part of the city coming together and experiencing different cultures, which I think is a must in growing cities. Showing that we are open to different cultures and projects, helps bring more people out of their homes and surrounding areas to the different sections of the city. This is key when you're trying to show off your city to investors or developers, because you what to show them what London has to offer to future employees.

2. I am currently the Chair of the Employee Association for the company that work for. Where I helped raise over \$3000, spread over multiple local charities in 2013, and looking to surpass that in 2014. I personally accepted a silver award at the Women's Community House Group Hug event on behave of our Employee Association donation back in June 2014. I don't always have the luxury of having time to volunteer because I'm busy working trying to keep a roof over my head and food on the table, so I donate where I can and help out when needed. You don't always need to volunteer to make a difference. Holding a door open and saying please and thank you goes along way. I am a strong believer in random acts of kindness, stopping and asking if people need help, or buying a cup of coffee for the person behind you in line, all these little charitable acts sometimes go unnoticed, but it makes London a better place to live.

3. If elected I will demonstrate my support for the nonprofit and charitable sector by continuing the funding that is needed to help promote the city and the sectors that help the people of London. Currently the city of London helps out almost 120 nonprofit originations and invests just over \$2.7 million to these companies. If elected I believe Londoners want to see where their tax dollars go and how their money helps out the nonprofit and charitable sectors. This information then will be posted on the City of London's website, so it is easy accessible to the public. This big move will help restore the faith in municipal politics, and help promote full transparency within the city and the organizations that have been assisted.

Kogelheide, Jim

1. London's nonprofit sector has experienced several challenges over the last four years because programs have not been receiving their needed funding. Street Connections is just one example. I plan on working with Council to ensure that the nonprofit sector receives more opportunities to prosper and grow to reach a high status with our community.

2. I am always working with the nonprofit and charitable sectors by creating fun and educational community events that promote sustainable lifestyles. This year, I worked with the Upper Thames River Conservation Authority to create a children's Earth Day parade and tree planting event. I'm also on the board of directors with TREA and this summer I created two programs with the Glen Cairn Community Resource Centre to provide local fruits for families living on fixed incomes.

3. This summer, I worked with the Glen Cairn Community Resource Centre to build two pilot projects that I would like to see become larger community projects over the coming years. Voyageur (my employer) donated a bus, I donated my time to drive the bus and the GCCRC took care of registration. We filled a bus with families living on fixed incomes and we went blueberry picking. The cost for our blueberries was less than 1/2 of the cost compared to store purchased berries, families saved money. The berry farm made more money and this helps to improve our local economy. Our carbon footprint was decreased because we didn't support the

shipping of berries from across the province and our berries weren't wrapped in plastic! A sustainable program with a lot of potential! I was also involved in creating this same program, but with strawberries and my desire is to build even more programs of this nature.

4. I am not a politician. I am a leader, a community planner with ideas that will improve our local environments while enhancing our ability to provide for our families in sustainable ways. For 19 years, I have been working with mayors of small communities, school boards and children's groups - from across Canada (including Nunavut) - to build programs that bring people together in positive ways. One of the reasons for my mayoral candidacy is to be in a position where I can continue to grow and expand on my 'grassroots' approach for improving the quality of people's lives so that I can bring more people together in more positive ways.

Lenart, Dan

1. One out of seven London households is on the social services. Province wide this works out to one million people. As a nation, Canada has 100,000 not-for-profit agencies, all competing against each other for shrinking resources. One of the problems that happens, especially in difficult economic times, is "social services turf warfare" - or the 'squeaky wheel gets the grease', instead of like minded agencies getting and working together. The City of London is in a position to help, because it is also one of the biggest landlords, and can offer places to meet for these community agencies, and can give them a break on the rent. Citizens with time, who are willing and able, can search and find the suitable agency through Pillar Nonprofit Network, and with the City's encouragement and resources get people further along the road.

2. I am involved in several nonprofit agencies, and have been for the last twenty-five years. It is a main reason why I'm running for Mayor.

3. I have been involved at the executive and board of director's level of several community agencies for many years. Working with the City of London has been an active part of this process with at least one of them, as they were the landlord. Writing grant proposals was also involved. I know first hand, the frustration felt on the front lines by these agencies, which face the possibility of shutting down on a daily basis. Another agency stopped its meal program, because of cut-backs by a City agency "London CAReS". These frontline agencies provide crucial assistance, in the trenches, and divert the most vulnerable among us, off the streets and back alleys. An ounce of prevention is worth more than a pound of cure. Police, fire, ambulance, lawyers, judges, jails, and hospitals cost millions if not billions of dollars compared to these much more modest and inexpensive local caring community agency solutions. It takes leadership, vision, planning, and a little financial injection to save much more on the other side.

4. The nonprofit sector is very important to me, but it does not get very much media attention, for the work it does. I would like to thank you for all your hard work.

Beynen, James

1. According to Statistics Canada, the charitable and nonprofit sector contributes an average of 8.1% of total Canadian GDP. On par with the retail trade industry and close to the value of the mining, oil and gas extraction industry. The numbers are staggering when you consider how little attention local government pays to it. Local governments need to do a better job investing in organizations that help develop the infrastructure to recruit, develop, place and retain volunteer talent as well as encourage young professionals to consider employment in the sector. This requires working directly with organizations in the sector but also umbrella organizations like Pillar Nonprofit Network with a mandate to provide leadership, advocacy and training.

2. I have experience in a number of local organizations in the sector and am currently a member of the Heritage London Foundation, Holy Rosary Catholic School Council, as well as the Medway Healthy Eating Healthy Physical Activity.

3. I would like to see London hold a "Voluntarism and Nonprofit" Fair drawing together organizations in the sector both to encourage voluntarism and increase interest from young professionals to consider careers in the sector. I would encourage London's academic institutions to participate in the "Fair" to ensure their graduates are drawn to the sector. In addition, I would like to establish a scholarship fund to be administered by a board drawn from the sector seeded with enough of a contribution from the city to make it a perpetual scholarship encouraging those considering careers in the nonprofit sector.

1. The City of London needs to leverage the skills, expertise and value of the nonprofit sector to develop a more comprehensive understanding of the way that our city works. Nonprofit organizations have a wealth of knowledge about the people that live in our city and the challenges that they face. I think that city councillors have to be aware of the work being done by nonprofit organizations to truly lay claim to a full understanding of our city. As a city councillor I believe that I have a responsibility to facilitate cross-sector conversations between nonprofits, government and for profit entities so that we can work together to address many of the societal gaps that still exist in London. If we properly engage nonprofit leaders in these kinds of conversations, our communities will stand a better chance of developing lasting strategies to address the challenges that they face. These challenges are directly linked to the economic future of our city. The nonprofit sector has direct contact with London's untapped labour market. Many Londoners have skills, abilities and potential but do not have the opportunity to contribute to London's economy. In order for London's economic revitalization to be truly successful, we must make sure that these individuals are given the chance to contribute. As a city councillor I would work hard to ensure that this human element of economic development is not forgotten as we work to secure London's economic future.

2. As of August 2013, myself and a group of Western University students started a nonprofit organization to provide educational, mentoring and job skill programs for youth. These programs link young people to adults in the community who can provide them with the necessary support to achieve their goals. uRelieve seeks innovative solutions to break the cycle of welfare dependency, joblessness and illiteracy. We believe in an education that allows students and teachers to discover and expand their capacity and joy for learning and to thrive through active participation in vibrant learning communities. We have partnered with the YMCA and we're currently awaiting a grant decision that would allow us to start our program in the fall. I have also been involved with the London Youth Advisory Council. I was elected in the spring of 2013 for a one-year term. The London Youth Advisory Council exists to ensure that youth voices are integrated into local public policy decisions. The LYAC is a youth government that amplifies youth opinion, on a diverse array of public policy issues, to the decision-makers in our formal governments and institutions. Councillors simultaneously learn and perform the role of a public representative by reaching out to their constituents through canvassing, social media, surveys, and outreach to youth organizations, public consultations and events. In addition, we received training in advocacy, policy writing, community development and public relations that strengthened our leadership skills. Alongside 12 other LYAC councillors, we represented over 73,000 youth in London, Ontario. We engaged in strategic planning and development both individually and collectively as a result of our participation in many municipal level and LYAC initiatives. We developed strong relationships with LYAC partner organizations, attended weekly working meetings with other councillors, and researched topics related to constituent issues as necessary. I also personally attended several community events each month to engage with youth, city leaders, politicians and others. I have also worked and volunteered with various other organizations and community groups

such as the London and Middlesex Local Immigration Partnership, London Food Bank and the Boys and Girls Club.

3. As I speak to Ward 6 residents I notice a great pride for London, but also a great desire to find the words to express that pride. I believe that London's identity will develop if we take the necessary steps to build a functional, connected and attractive city. Functional means having a fair tax system, a government that works and a vibrant democracy; connected means bringing people together through smart investments in infrastructure, programs and ideas; and attractive means providing the necessary supports to make London a place where people want to start and grow businesses, families and lives. Part of having a functional government is building a City Council that knows how to listen. That's why I am committing to 100 Days of Listening (focus groups, community discussions, further ward canvassing, etc.) so that I am able to gain a grasp on the many organizations, individuals and ideas that make up the City of London. One of the most significant lessons I learned through my own volunteer work in the nonprofit sector is that nonprofit organizations tend to fill a gap between available public services and private fee-bearing services. This is true of a range of organizations, be it the London Food Bank or a nonprofit athletic association. How I would specifically support each type of organization would depend on the organization itself, but I certainly intend to ensure that these types of organizations receive the support that is needed from the City of London to fill the gap. This could be accomplished by ensuring there is a specific sum set aside in the budget to provide grants as support for these organizations or by simply endeavouring to sit down with these organizations regularly to determine what the City of London can do to play a role in the work they do. I also intend to continue my own philanthropic work as a city councillor.

1. I agree that the nonprofit sector plays a vital role towards the rejuvenation and well being of London. This sector, supported over the last decade by Pillar Nonprofit Network contributes to our quality of life through various social services to support our vulnerable population, recreation, culture, health, community, sports, elder, child care, employment, business counseling, and more. Specifically, Pillar Nonprofit Network is leading the way with social innovation and social enterprise that promotes and supports partnerships between business and community partners. As city councillor, I would work closely with London's not for profit and charitable network of organizations to ensure that I understand the vision, mission, impacts and benefits of existing and proposed programs and initiatives for the community. This will allow me to be a strong advocate as I work to endorse and champion organizations and/or initiatives as community priorities. Coupled with a solid business plan, I would advocate that these initiatives would have access to council directed funding, or through the funding to granting programs and as identified in the budget, so as to enable these organizations to harness and engage citizens to build a strong, economically prosperous London with quality of life in which people will want to live, work and invest.

2. I have acted as a community builder and advocate for many years – I like to think of it as community entrepreneurism. I have been a member of the Hyde Park Business Association (HPBA) for over six years in a variety of roles that include secretary, vice president and current

president. During this time, I have advocated for businesses and the community on matters pertaining to impending zone changes and other concerns or issues related to the area. Over the last four years, I have worked with the Hyde Park Road Widening Committee, a collective group of community members along with representation from the City of London (Project Mangers, Engineers, Planners, etc.) to mitigate the impacts of the Hyde Park Road widening scheduled to conclude in 2015. Working with the HPBA, we were successful, by working with the incumbent councillor of the day, to have the construction process reduced from three to two years. I am also working with this committee, the City and the Hyde Park Business Association with discussions for future visions and enhancements in the Hyde Park/Gainsborough Road area. On another note, after hearing that many children cannot go outside for recess in the winter without appropriate boots, I worked collaboratively with the HPBA Association, local businesses and the community to launch the "HPBA Annual Boot Drive". The Association has collected and donated to Mission Services over 600 pairs of boots - helping to keep toes warm. As chair of the Santa Clause Parade Committee, we have participated, since the inception of the Hyde Park Santa Parade with a float garnering help with the design and decorating from Oakridge Secondary School students while helping them gain volunteer hours. After, two years in the making, I worked closely with the Hyde Park Business Association, collaborating with local businesses, the City of London and many other stakeholders to launch London's first Outdoor Community Piano dubbed the "Piano Project" this spring. Apart from the Hyde Park Business Association, and as a big believer in entrepreneurial endeavors, I believe that selfemployed individuals / families and small business are going to be the economic backbone to London's recovery. Hence my recent past involvement for 3 years in the "Send a Kid to Camp Business Basics" program designed to raise money to send kids (who otherwise would not have the opportunity) to attend the Junior Achievement London's summer camp program. It is inspiring to help light that "entrepreneurial spark" in the youngest and brightest! Partnerships are key, and as such I work with community based organizations such as the NorWest Optimists to support our youth and families. I am working with the Goodwill Career Centre (Sherwood Forest Mall) employing youth, and I am currently collaborating with the NorthWest London Resource Centre regarding youth employment placement programs with businesses in North West London. As well, I have been in discussions with Over 55 as it relates to their programming and getting our older demographic to work. I sit on the marketing committee with the London & Region Fundraising Executives (LRFRE) which supports the nonprofit sector by promoting a standard of ethical practices and code of conduct for those working in the fund raising field. For the past three years, my business has and continues to be a sponsor of this organization to support the important work that they do both within the sector and in the community. After 14 years, I continue to be a member of the London & Middlesex Child Safety Committee led by the Middlesex London Health Unit; helping to support young, growing families with pertinent programs and information so as to promote healthy, safe environments and communities to thrive. This committee has a seat and voice on the City of London's Community Safety and Crime Prevention Advisory Committee (CSCP) Lastly, involved in 2007/2008 as part of the organizing team, I continue to work with London's Clean and Green initiative as Captain in the Hyde Park area.

3. The collaborative approach towards creating partnerships between the nonprofit, business and government sectors in London plays an important role in the community, and as such, I would continue with my own personal involvement within the nonprofit, charitable sector at various levels. I am confident that this exciting, collaborative-based initiative will have a large impact towards London's recovering economic prosperity and job creation. I support and believe in the concept of Social Enterprise. Owned by nonprofit organizations, the idea of operating for the social good by using a business methodology in the production of and selling goods and services to generate income is a good one. This allows these enterprises to build baseline dollars to invest and contribute back towards healthy, vibrant communities while meeting their vision and mission - being less dependent on government funding at all levels and donations. Social community entrepreneurism at its best. In fact, at Neighbourhood Watch London, I led this model with the sales of "Home Finder Plates" to help fund special programs.

1. The city spends about \$2.25M in funds for the nonprofit sector (amount roughly equivalent to that provided to the London Economic Development Corporation). This funds a wide variety of organizations and programs, from established arts and cultural groups like the Grand and the Orchestra to small neighbourhood festivals.

I would suggest that we need a comprehensive report on the value of the services provided by nonprofits, the number of jobs involved, the number of volunteer hours, etc. This data is already available at the national and provincial level but we need that at the local level so that councillors and residents alike can appreciate the return on investments that not-for-profits have.

We need to review funding for not-for-profit organizations to ensure that we maximize the revitalization that this sector can provide. Needs and priorities change over time; some organizations may be past their best before date or self-sustaining, while others receiving little or no funding will be able to make significant contributions given adequate resources. We need to give recognition to the non-profit sector. The current featured community organization is excellent but would get more attention from the public if the awards were made prior to the public business of the council. There are few people in the public gallery to witness the awards at 4 p.m. since council goes in camera immediately following the awards.

2. As a Toronto teenager, I worked with youth at drop-in centres and summer camps in the city core and also was a candy striper at a local hospital. Shortly after coming to London nearly thirty years ago, I became involved in a number of community organizations including being treasurer for Oak Park Pre-school, serving on a building committee to construct a day care centre, being treasurer for the Byron Home and School Association, and serving on the executive board of the London United Soccer Club. I have been a member of the Urban League of London since 1999 and served on the executive/director's board from 2002 to 2013. I have served as fundraising chair, treasurer and director, represented the League on a number of City committees and worked on League committees such as Civics 101 (Why should young people vote?) and organized debates on why the City needs an integrity commissioner. The League is an umbrella group of approximately 26 community groups and individuals throughout the City

1. There is no denying the importance of the nonprofit and charitable sectors in the City of London. There are approximately 900 registered charities in London and many nonprofits that are not registered as charities. These organizations typically provide services that would not otherwise be available - performing arts, athletics, and social services to name a few. These organizations merit support from the taxpayers of London. The difficult question to answer is "how much support and what kind of support?" There is not a blanket answer to what seems a simple enough question. Support must be determined organizationally on a case by case basis. And, support will be determined by the case for support that is put forward by the organization. The City of London is not, nor should it be, the sole source for funds. Organizations must explore all avenues for support. However, there is no reason that the taxpayers of London, through the City, cannot be supporters of these sectors. I believe that the City can offer more than just operating or capital funds to organizations. There are many small organizations that would benefit greatly from such mundane things as a place to meet occasionally and insurance coverage for community events. I believe that the City is large enough that the associated risks are very manageable. I believe that the City has the ability to facilitate collaboration amongst organizations in the nonprofit and charitable sectors. Within these sectors networks of like organizations are very important. The City of London support for Pillar Nonprofit Network provides some wonderful tools to ensure this collaboration continues.
